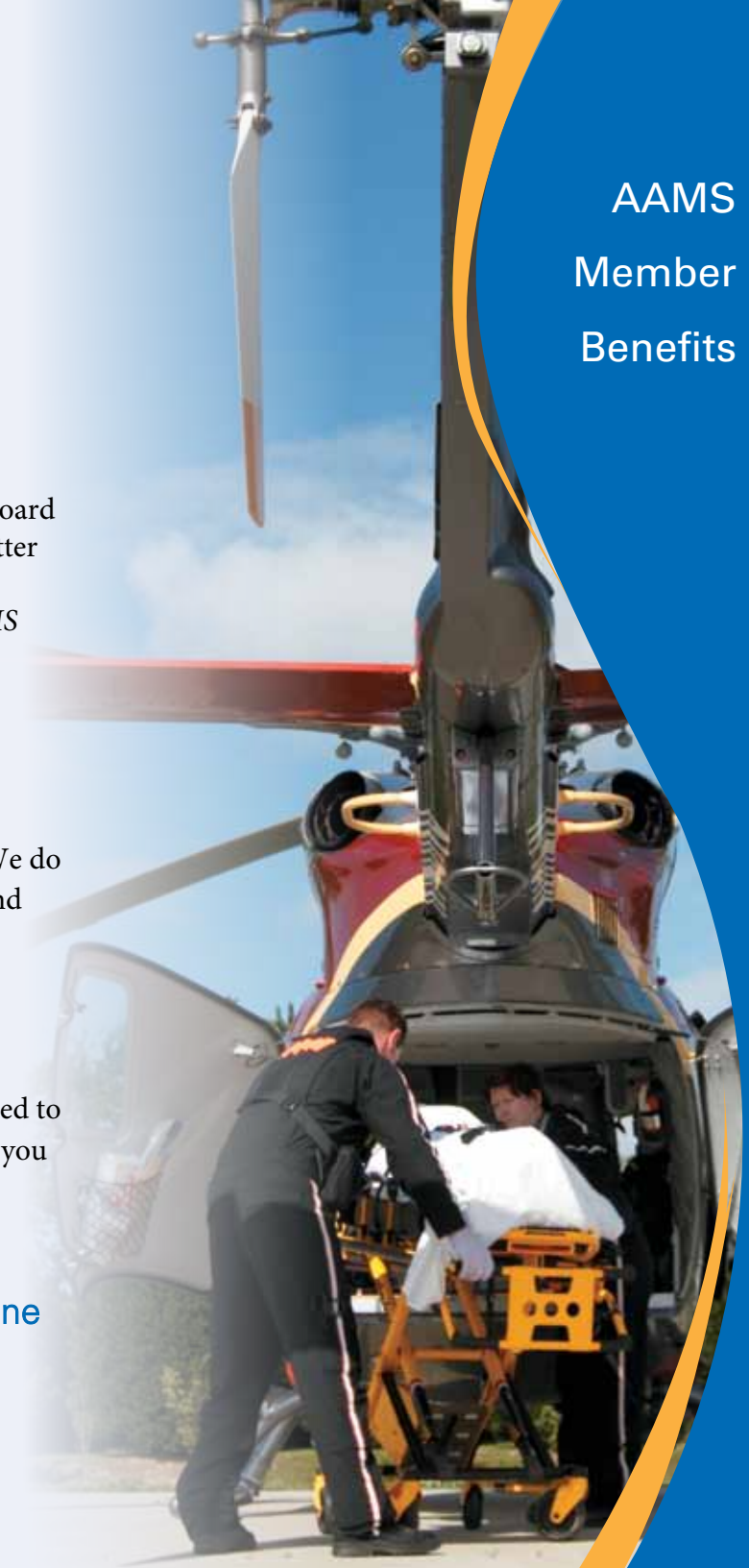

**International Discounts:**

Discounts of up to 20% off the standard dues rate will be available to members outside the United States if they are located in countries where the purchasing power of their currency is less than 80% of that in the United States. The discount will be calculated proportionally based on the comparison of purchasing power of the specific country with that of the US.
